
TN Tech Wesley Foundation's annual fundraiser on April 1st has a very special guest this year! **Bishop McAlilly!!!**



Persecuted Christians Please remember the following in your prayers.

Pastor Derek Reimer (36 yrs old): was protesting a drag queen story hour at a library. Video of the event shows him being forcibly dragged from the room & thrown to the ground. The following day he was arrested & charged with one count of mischief, one count of causing a disturbance & six "bylaw charges" that carry a potential penalty of \$10,000 per charge & jail time if default of payment occurs. No other individuals were charged for their actions. (Calgary, Canada)

Mid Vermont Christian School Girls Basketball Team: the team withdrew from a state sponsored tournament rather than compete against an opponent with a biological male on the team. MCVS Administrator Vicky Fogg stated the presence of a male on the team jeopardizes the fairness of the competition, presents a safety concern for their female athletes & in general sets a bad precedent for the future of women's sports. The school was subsequently barred from participating in any tournament in any sport sponsored by the Vermont Principals Association. (White River Junction, Vermont, US)

The Department of Education is attempting to delete a 2019 regulation that allows the federal government to withhold funds from colleges/universities that violate religious student organizations first amendment rights. The administration contends the rule is unnecessary to protect students first amendment rights & their free exercise of religion. Additionally, DOE claims the regulation places undue burdens on the Department to investigate claims of violations. First Liberty Institute, who regularly represents students whose religious rights have been violated, noted it's unclear how this regulation could be burdensome as the DOE can only withhold federal funds following a final, non-default judgement from a court. (US)
